Abstract:

The research sheds light on postmodern art as a modern intellectual approach, which contributes in turn in establishing artistic authenticity for textile pendants. Accordingly, the researcher observed that there is one of the latest contemporary art schools which is postmodernism, which appeared in response to modernism which started in Europe since the moment when religious culture disintegrated and the secular culture based on intellect appeared, opposing all missiological principles. This terminology appeared in guides distinguishing between two time periods represented by conflict between old and new, with the affirmation of disconnecting with the past period with the beginning of the age of advancement and renewal. Then, going past that to the contemporary period, which implicitly means modernizing. As modernization and contemporariness are twins of modern secular ideology. Mandalas are drawings in the form of intertwined squares, and circles with no beginning nor end. Others combine square and circle. They are a group of symbols used by Hindus to express the image of the universe (metaphysics) and it is a Sanskrit word meaning circle, and has now become a common term for any circular design with a repeated or geometric pattern. Here the research's issue is determined in how to benefit from the aesthetic values of the art of mandala and employ them in the design of textile pendants, and how to treat artistic units and harness them through some computer programs specialized in design, to innovate designs for textile pendant printing. The research aims to shed light on the art of mandala as one of the contemporary arts (postmodern arts) and clarify the difference between it and other kinds of art, and how to benefit from it in designing textile pendant prints.
